- 1. Meeting opened at 6:30 pm.
- 2. (a) Steve reported water meters have been read for the 1st quarter.
 - (b) The Consumer Confidence Report for 2022 was mailed with the water bills.
 - (c.) Steve got a price for a new interrogator and the computer set up at \$5,868.00. Terri and Steve are going to look into the possibility of sharing the unit and the cost with the Village of North Troy, if it is possible with the program.
- 3. (a) Mike reported during the last big rain storm a culvert failed on River Road. A vehicle went through and had extensive damage done to their truck. VLCT Insurance was notified, however, they did not pay for the claim, as it was not the fault of the town.
- 4. (a) Roger Morin gave a cemetery update.
 - (b) He brought pictures of various broken tombstones and indicated his intent to fix as many as he can this summer with mortar, as the epoxy has not worked well.
 - (c) Gaston let Roger know he would be ordering American flags to put on the graves and having them mailed directly to him.

- 11. 8 Liquor Licenses were approved.
