BOARD OF SELECTPERSONS MINUTES

The Board of Selectpersons held their monthly meeting on Tuesday, July 18, 2023, at

6:30 p.m. at the Troy Municipal Office.

- 1. The meeting opened at 6:30 pm.
- 2. Steve did not attend the meeting, however, Robert read a report from Steve indicating that the water plant and well house were spared from any flooding. Steve also inquired about Derek Medley's current pay rate with the water department. Steve explained in his letter that Derek currently earns less money per hour when working for the water department than the sewer department. During a recent water leak, Derek made less money that day to work at the water leak than he would have if he was working with Steve doing his regular job in the Sewer Department. A motion was made by Gaston that Derek's rate for the water department be raised to \$19.54, retroactive to June 1, 2023.
- 3. (a) Mike reported all roads are now open from the flood, however, not all work has been completed. With the high waters many culverts have failed. He will be replacing 6 culverts on various roads.

(b) The first cut of mowing roadside is completed.

(c) During the flood someone drove through the flooding waters on Veilleux and their car is still on Richard Veilleux's property. Mike got the OK from the board to have the vehicle towed.

(d) Mike reported he had a flat tire on his personal truck on the morning of the flooding. He asked the board if they would pay for a percentage of the cost of four new tires. A motion was made by Gaston to purchase two tires for the road commissioner's pickup truck, due to extreme use of his truck during the present store, with the approval of the estimate. Robert can act for the board once the estimate is received.

(e) Mike inquired if some of the APRA monies could be used to make the garage longer, where they park the town trucks. Currently the trucks barely fit into the spot and the plow hits the back of the building. Mike is going to ask Randy Choquette for a cost estimate.

- 4. Excessive speeding on town roads was discussed. Gaston is going to call the Sheriff's Department and ask them to do a speed study.
- 5. Minutes from the June 20, 2023, meeting was approved by a motion made by Anne.
- 6. All Orders were approved.
- 7. All delinquent property taxes and water/sewer accounts were reviewed. Any balances due over \$250 will be included in our annual tax sale in September.
- 8. The board spoke with Vanetta from Kevaco regarding updating our website. We looked at various town websites throughout the state. We will continue the discussion at the next selectboard meeting.
