- 1. Meeting opened at 6:31 pm.
- 2. Steve gave a water dept. update. The line leaking on Mill Street has been replaced. The line running to Stacey Kennison's on River Road needs to be looked at, as there is a possible leak there.

  Steve reminded the board of a 5 year warranty with Pureflow and is going to have them come and inspect the equipment before the end of the year.
- 3. Corey Spaulding from the local ATV club asked the Board to open up more of Collins Mill Road, Carter Road and Loop Road to ATVs. He presented the Board with a copy of their insurance policy and let them know the ATV trails are actively policed by game wardens and the sheriff's dept. Mark questioned the damage that could be caused on the back roads as a result the opening those roads to the group.
